PHILIPPINE WAR

Historical Context

- Following the Spanish American War, the United States decided to keep control of the Philippines as a US Possession instead of granting independence
- The Filipinos, led by Emilio Aguinaldo, rebelled against American control.
- The resulting war lasted three years and cost many lives.

PHILIPPINE WAR

Read the documents at <u>THIS LINK</u> and then use them to complete the activity on the next slides.

Create the chart on the next slide in your notes and use the documents to record supporting evidence for each historical point of view, then evaluate each point of view independently based on the evidence you found. The overall evaluation where you compare the points of view will happen on the slide after.

USING HISTORICAL EVIDENCE

- **Hypothesis 1** American soldiers who brutalized Filipino insurgents were simply following orders
- **Hypothesis 2** American soldiers who brutalized Filipino insurgents thought Filipinos were less than human
- **Hypothesis** 3 American soldiers who brutalized Filipino insurgents were getting revenge for how Filipinos treated American soldiers.
